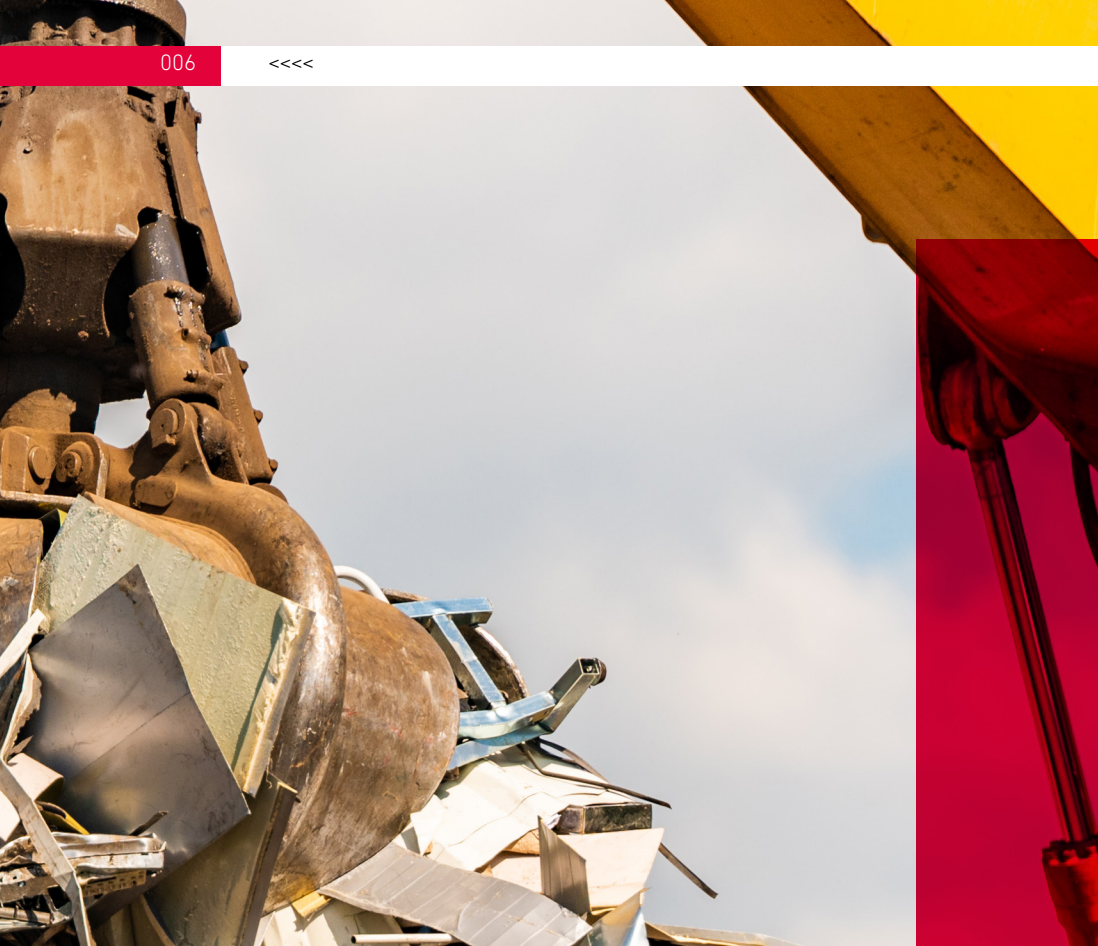
Initially, the company emerged as a frontrunner in the scrap metal and waste management

IPPC is a European framework designed to prevent and control pollution.

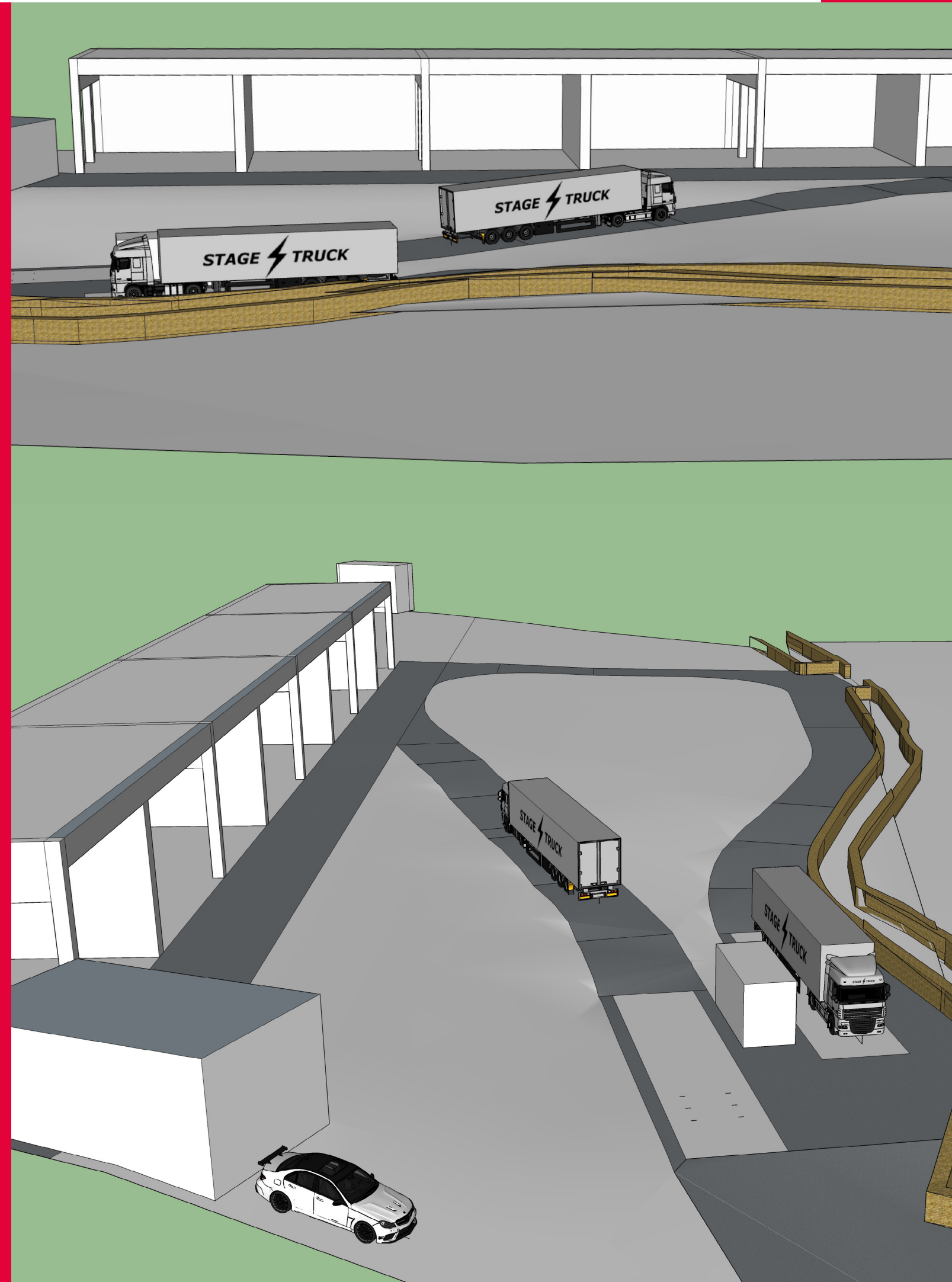
